# Master of Gastronomic Tourism.

**Le Cordon Bleu award an annual AUD\$5,500 tuition scholarship (equivalent to two units from the Le Cordon Bleu Master of Gastronomic Tourism program) to an outstanding industry professional to further their food and tourism education.**

## 2017 Industry Professional Scholarship.

### Who can apply?

This scholarship is open to all industry professionals who are currently working or have worked in the food, wine, tourism or hospitality industries in some capacity in the past six (6) months. This includes chefs, sales/ marketing/ event managers, cellar door operators, hotel management, entrepreneurs and consultants and those working in food manufacturing.

### Conditions of the Scholarship

All applicants for this scholarship:

- > need to meet the eligibility criteria for entry into the program.
- > will need to submit evidence of their relevant experience.
- > will need to approve of being interviewed/ photographed for marketing purposes, and where requested provide a quote detailing their experiences in the program. This may occur at various times throughout the duration of their scholarship period.

### Application process

All applicants need to:

- > submit an application form for the Le Cordon Bleu Master of Gastronomic Tourism and a scholarship application form.
- > submit any evidence of their relevant specialist experience; this may be in the form of certificates, professional memberships, written professional references and a current resume.

- > submit their response to the following:

**Part A - In less than 25 words tell us what gastronomic tourism contributes to industry.**

**Part B - In 250 words or less tell us how this scholarship will enrich you as an industry professional.**

All applications will be considered by a panel of three judges convened by the Le Cordon Bleu Sales Manager, and Le Cordon Bleu Educational Manager, Leadership.

The scholarship recipient and all other applicants will be advised by email no later than **Friday 9 December 2016.**

Part-tuition scholarships may also be awarded at the discretion of the panel.

Unsuccessful applicants will need to advise Le Cordon Bleu if they wish to pursue their enrolment into the program.

The applicant will be expected to commence studies in the program in the February 2017 (Session 1) intake.

**Applications will close on Friday 28 October 2016.**
