

Available to new students only. A limited number of scholarships are available.

Assessment Criteria: Applicants will need to complete a Le Cordon Bleu Australia Application form (and meet the associated entry criteria) as well as agree to the conditions of this scholarship form. Applicants are also required to prepare a 400 word essay as part of their application.

- Applicants must meet the eligibility requirements as set out for each scholarship.
- 2. Applicants must be over 18 years old.
- Applicants must currently be a citizen or permanent resident in one of the following South American countries: Argentina, Bolivia, Brazil, Chile, Colombia, Ecuador, Guyana, Paraguay, Peru, Suriname, Uruguay, Venezuela, Trinidad and Tobago and Panama.
- 4. Applicants will be assessed according to the assessment criteria for entry into Le Cordon Bleu Australia programmes combined with their essay submission.
- 5. Scholarship recipients agree to become ambassadors of Le Cordon Bleu, undertaking activities agreed as reasonable and acceptable by the scholarship recipient and Le Cordon Bleu including: attending recruitment events; answering enquiries of prospective students; and contributing short articles and images for newsletters and blogs.
- The scholarship is non-transferable and the recipient must commence studies with Le Cordon Bleu Australia in 2019.
- 7. The scholarship recipient must be enrolled on a full-time basis.
- 8. The scholarship is allocated as follows
 - \$10,000 Tuition Scholarship towards the Certificat de Chef de Partie
 Cuisine SIT40516 Certificate IV in Commercial Cookery or Certificat
 de Chef de Partie Pâtisserie SIT40716 Certificate IV in Pâtisserie will be
 allocated as an AUD\$10,000 fee waiver for the final 6 month
 component of the programme of study
 - \$15,000 Tuition Scholarship towards the Diplôme Avancé de Gestion Culinaire – Cuisine/ Pâtisserie - SIT60316 Advanced Diploma of Hospitality Management will be allocated as an AUD\$5000 fee waiver for the final 'superior/ commis' component of the SIT30816 Certificate 3 In Commercial Cookery or SIT31016 Certificate 3 In Pâtisserie AND an AUD\$10,000 fee waiver towards the final 6 month component of the SIT60316 Advanced Diploma of Hospitality Management
- The scholarship recipient must successfully meet the study requirements of each stage of the programme and adhere to programme rules to be awarded each consecutive period of fee waiver.
- If the scholarship recipient fails any subject during the programme they financially responsible for any re-enrolment costs and fees.
- 11. Scholarship is a tuition fee waiver or fee reduction only.
