Background

A tuition scholarship (valued at \$AUD6220) will be awarded annually to an outstanding gastronomic enthusiast to undertake two units from the Le Cordon Bleu Master of Gastronomic Tourism programme.

Who can apply?

This scholarship is open to all professionals who are currently working or have worked in a food, travel or education related role.

Conditions of the Scholarship

- All applicants for this scholarship need to meet the eligibility criteria for entry into the programme.
- All applicants for this scholarship will need to submit evidence of their relevant experience.
- All applicants for this scholarship will need to approve of being interviewed/ photographed for marketing purposes, and where requested provide a quote detailing their experiences of the programme. This may occur at various times throughout the duration of their scholarship period.

Application Process

1. All applicants need to submit an application form for the Le Cordon Bleu Master of Gastronomic Tourism **AND** the scholarship application form.
2. All applicants also need to submit any evidence of their relevant specialist experience; this may be in the form of certificates, professional memberships, written professional references and a current resume.
3. All applicants need to submit their response to the following;

Part A. In 25 words or less tell us how this scholarship will assist you in your career.

Part B. In less than 300 words outline three (3) things you would do to either kickstart or value-add a gastronomic tourism destination.
4. All applications need to be scanned and emailed in high resolution or posted to:
5. All applications will be considered by a panel of three judges convened by the Le Cordon Bleu Sales Manager, and the Le Cordon Bleu Manager, Educational Leadership.
6. The scholarship recipient and all other applicants will be advised by email no later than **Friday 1 December 2017**.
7. Part-tuition scholarships may also be awarded at the discretion of the panel.
8. Unsuccessful applicants will need to advise Le Cordon Bleu if they wish to pursue their enrolment into the programme.
9. The applicant will be expected to commence studies in the programme in the February 2018 (Session 1) intake.
10. *Partially* completed applications will not be considered.
