## 6. ADMISSION POLICY

### 1 Purpose

1.1 The objective of our equal opportunities policy is to provide a set of principles that support the provision of Le Cordon Bleu education services in Rio de Janeiro and a learning environment free of discrimination of any kind.

### 4 Requirements

4.1 **Age:** The candidate must be at least 18 years of age.

4.2 **Language:** Our courses are conducted in Portuguese and students are expected to demonstrate a proficiency in spoken and written Portuguese.

4.3 **Secondary:** A Secondary Diploma (Brazil), Secondary Diploma (USA), Secondary Certificate (Japan), GCSEs (England), Baccalaureat (France). Other qualifications will be accepted by the admission jury as evidence of prior study and apprenticeship if the candidate can demonstrate that the qualification is of academic standard equivalent to the above examples.

## 1. ADMISSION

The admissions team will be responsible for assessing the profiles of candidates, considering their qualifications, proficiencies and aspirations of the candidate and guide them on the courses offered by Le Cordon Bleu.

## 2. QUALIFICATIONS

The minimum qualifications of candidates for courses offered by Le Cordon Bleu consist of being a holder of a Secondary Diploma (Brazil), a Secondary Diploma (USA), a Secondary Certificate (Japan), GCSEs (England), Baccaureat ( France). Other qualifications may be required by the admission committee as evidence of prior study and apprenticeship if the candidate can demonstrate that the qualification is of academic standard equivalent to the above examples.

## 3. APPROVAL

After reviewing the individual qualifications and the application form, the applicant must comply with and comply with the provisions of the Le Cordon Bleu Terms and Conditions (as defined

below). In addition, (i) the motivation of the students to study the programs offered by Le Cordon Bleu; and (ii) its future aspirations stated in the "motivation letter" which must be submitted by the candidate on the application form. In case of refusal to admit a candidate, the candidate may appeal in writing within 14 days from the receipt of said negative response, addressed to the director of InstitutoLe Cordon Bleu Rio de Janeiro, whose decision on admission is final and definitive.

## 4. GENERAL CONSIDERATIONS

- No candidate / student may use the name and / or logo "Le Cordon Bleu" and / or similar names or logos under any circumstances or at any time or in any place (including the internet), whether before, during or after training and be as a trademark, business or trade name, domain name or otherwise.
- All students must abide by the school's internal rules.
- Le Cordon Bleu does not assume obligations in case of accident, loss, damage, civil liability of the student or other similar cases. All students are required to take out adequate insurance to cover these risks during their studies.

## 7. TERMS AND CONDITIONS OF PAYMENT, DELAY AND CANCELLATION ("TERMS AND CONDITIONS")

### 1. REGISTRATION AND PAYMENTS

1.1. The duly completed registration guarantees the reservation of place in the chosen course. In order to complete your registration, the applicant must pay in full and in view of the registration fee, which includes the registration fee and the sign of 10% (ten percent) in relation to the total amount of the course ("Registration Fee" ), within 8 (eight) weeks prior to the start of the course ("Enrollment").

1.2. In addition to the Registration Fee, until the first day of class, the student must pay the Kitchen Kit, to be determined by Le Cordon Bleu for each course. The Kitchen Kit (utensils and uniform) consists of equipment for personal use and independent of the course.

1.2.1 Only the holders of the respective Kitchen Kit will be able to participate in the classes, being

certain that the Le Cordon Bleu will have the right to not allow participation of those who have not purchased the Kitchen Kit.

1.3. In addition to paying the Registration Fee and the Kitchen Kit, in order to enroll in the course, the applicant must send the completed and signed Application Form to [riodejaneiro@cordobleu.edu](mailto:riodejaneiro@cordobleu.edu)

1.4 If the candidate is a foreigner, he+ must also present a student visa within 8 (eight) weeks before the beginning of the course, failing which his enrollment in the course will not be effective.

1.5. If, due to the candidate's sole fault, any of the obligations that make up the Application cease to be fulfilled, Le Cordon Bleu shall have the right to cancel its enrollment in the course and to retain in full the payment related to the Enrollment Fee already made by the candidate.

1.6.1.1. For international bank transfers, all payments, including the Registration Fee, the Kitchen Kit and the remaining installments of each of the courses offered by Le Cordon Bleu, will only be received by Le Cordon Bleu in US Dollars, and the bank transfer receipts must be sent to [riofinance@cordobleu.edu](mailto:riofinance@cordobleu.edu).

1.6.2. All bank fees incurred when transferring funds to Le Cordon Bleu are the responsibility of the candidates. Any bank fee, relating to the payment of the Registration Fee or the course, will be charged to the candidate.

## 2. POSTPONEMENT

2.1. Any student may postpone only the start of the program for a later period, provided that such request is approved by Le Cordon Bleu. The maximum period allowed for postponement is 3 (three) months from the first day of the original course postponed. To postpone the course, the student must, within 8 (eight) weeks before the first day of the course, send the completed Completion Form to [riodejaneiro@cordobleu.edu](mailto:riodejaneiro@cordobleu.edu)

2.2. Le Cordon Bleu will only accept the course postponement request if there are available vacancies available in the course intended by the candidate (based on the calendar of classes and courses of Le Cordon Bleu Rio de Janeiro).

2.3. If the request for postponement is not accepted, Le Cordon Bleu will not reimburse the Registration Fee and the Kitchen Kit value that has already been delivered to the student.

2.4. If the deferment is accepted by Le Cordon Bleu, the student may cancel the amounts paid as a Registration Fee of the new Registration Fee and other amounts due at the time of the resumption of the deferred course.

2.5. The student will be responsible for all and any registration costs and higher values if the course chosen to be taken in the subsequent period presents costs or values that are more expensive than the deferred course. If the new course chosen has lower costs or values, Le Cordon Bleu will not refund the difference.

2.6. If a visa is rejected, a candidate wishing to postpone registration must send a digitized proof of visa refusal (a copy of the passport stamped with a visa refusal, a letter from the Consulate), to [riodejaneiro@cordobleu.edu](mailto:riodejaneiro@cordobleu.edu), within three (3) days after receiving the denial notification. After this period and / or if the candidate does not send any proof of refusal, the request for postponement will not be accepted. In this case, the Registration Fee and the Kitchen Kit, which has already been delivered to the applicant, will not be refunded.

2.7. Except for (i) Intermediate Cuisine, Superior Cuisine, Intermediate Pâtisserie and Superior Pâtisserie courses, which must be continuously and uninterrupted, and (ii) demonstration courses for which there will be no refunds or postponements, all other courses of Le Cordon Bleu may be subject to the request for deferment.

3.1.1. If the student who has timely (i) made the full payment of the Registration Fee; (ii) submitted a student visa (if applicable); and (iii) deliver to Le Cordon Bleu your duly completed and signed Application Form, you wish to cancel the course not yet started, within 7 (seven) days from the date of payment of the Fee

3.1.2. Le Cordon Bleu will not reimburse the Enrollment Fee and, if the student wishes to cancel the registration after 8 (eight) weeks before the beginning of the chosen course, by completing the Cancellation Form, value of Kitchen Kit that has already been delivered to the student.

3.1.3. In case of cancellation:  
[riodejaneiro@cordobleu.edu](mailto:riodejaneiro@cordobleu.edu), containing the student's full name and the course in which he is enrolled, being sure that the request will be analyzed by Le Cordon Bleu, who will decide in his sole discretion.

3.1.4. In the case provided for in clause 3.1.2, a compensatory fine of 15% will be levied on the amount of the installments falling due to the course.

3.1.5. If payment of the course has been made in cash or, if there is a payment of more amounts by the student, in case of cancellation after the start of the course, in addition to the compensatory fine of 15% on the value of the installments falling due, Le Cordon Bleu will not refund to the student the value of the Registration Fee, the value of the Kitchen Kit and the values referring to the classes already taken. Le Cordon Bleu will refund, therefore, only the

Registration, the Kitchen Kit and the delivery of the Registration Form ("Cancellation by Repentance"), it will receive a refund of all amounts paid.

amount of the remaining months paid, within 30 (thirty) working days, counted from the sending of the Cancellation Form.

3.1.6. Values referring to classes / periods studied will not be reimbursed in any case to the student.

### 3.2. By Le Cordon Bleu

3.2.1. If the course is canceled by Le Cordon Bleu, for any reason, excluding unforeseen or unforeseeable circumstances that may be proven, the Enrollment Fee and tuition fees paid by the student will be fully refunded or transferred, with the student's permission, to another program of his choice. The amount of Kitchen Kit that has already been delivered to the student will not be refunded.

3.2.2. In the event of unforeseen or unforeseeable circumstances that may be proven and Le Cordon Bleu is unable to continue offering the course chosen, the student will receive reimbursement in proportion to the classes that were not given. Also, in this case, Le Cordon Bleu will not reimburse the Registration Fee and the Kitchen Kit value that has already been delivered to the student.

## 4. GENERAL PROVISIONS

4.1. The student undertakes to notify Le Cordon Bleu of any changes to his personal data by e-mail [riodejaneiro@cordobleu.edu](mailto:riodejaneiro@cordobleu.edu). In addition to the penalties provided by law, any false information provided by the student may result in the refusal or cancellation of the Registration, at any time, without reimbursement of any amount already paid.

(iii) If the cancellation is requested after the period specified in item "i" above, Le Cordon Bleu will retain the Registration Fee and the Kitchen Kit amount. Still, amounts referring to periods already taken will not be reimbursed in any way to the student; and

(iv) If the cancellation is requested after the start of the course and the payment has been made in cash or if the student has paid more, in addition to the compensatory fine of 15% on the value of the installments, Le Cordon Bleu will retain from the student the value of the Registration Fee, the value of the Kitchen Kit and the values referring to the classes already taken. Le Cordon Bleu will only reimburse the amount of the remaining months paid, without monetary adjustment or interest, within 30 (thirty) working days, counted from the sending of the Cancellation Form.
